I, S. Samdani, Partner, Samdani Shah & Kabra, Company Secretaries, have been appointed as a Scrutinizer by the Board of Directors of **Shaily Engineering Plastics Limited** ("Company"), for the purpose of scrutinizing the e-voting process conducted for transacting the business as mentioned in the Notice dated August 11, 2025, convening 45th Annual General Meeting ("AGM") of the Members of the Company, which was held on Saturday, September 27, 2025, at 10:30 A.M.
